**THE CORPORATION OF THE CITY OF DAWSON CREEK****BYLAW NO. 4278, 2016**

A Bylaw of the Corporation of the City of Dawson Creek (hereinafter called "The City") to regulate the municipal ticket information system in the City.

**WHEREAS** Section 264(1)(a) of the *Community Charter* empowers the City of Dawson Creek, by bylaw, to designate those bylaws for which municipal ticket information may be used as a means of bylaw enforcement;

**AND WHEREAS** Section 264(1)(c) of the *Community Charter* empowers the Council to, by bylaw, authorize the use of any word or expression on a municipal ticket information to designate an offence against a bylaw;

**AND WHEREAS** Section 265(1) of the *Community Charter* empowers the Council to, by bylaw, set fine amounts;

**AND WHEREAS** the Council deems it expedient to authorize the use of municipal ticket information for the enforcement of certain bylaws, to authorize the use of certain words or expressions to designate certain bylaw offences and to set certain fine amounts.

**NOW, THEREFORE**, the Council of the City of Dawson Creek in open meeting assembled enacts as follows:

**SECTION 1 - TITLE**

- 1.1 This Bylaw may be cited as "**Municipal Ticket Information System Bylaw No. 4278, 2016**".

**SECTION 2 - DEFINITIONS**

- 2.1 In this Bylaw the following terms have the following meanings:

"**Bylaw Enforcement Officer**" means a person or persons appointed from time to time by resolution of City Council pursuant to Section 36 of the Police Act, the purpose of which is to enforce regulatory bylaws of the municipality.

"**City**" means The Corporation of the City of Dawson Creek.

**SECTION 3 - GENERAL PROVISIONS**

- 3.1 The persons who act in the job positions or titles listed in Column A4 of Schedule "A" to this Bylaw are designated Bylaw Enforcement Officers for the purpose of enforcing the bylaws listed in Column A2 of Schedule "A" opposite the respective job position.
- 3.2 The Bylaws listed in Column A1 of Schedule "B" to Schedule "Z" of this Bylaw may be enforced by means of a ticket in the form prescribed for the purpose of Section 264 of the *Community Charter*.
- 3.3 The words or expressions set forth in Column A3 of Schedule "B" to Schedule "Z" of this Bylaw designate the offence committed under the bylaw section number appearing in Column A2 of Schedule "B" to Schedule "Z".
- 3.4 The dollar amounts in Column A4 of Schedule "B" to Schedule "Z" of this Bylaw are the fines for the corresponding offences designated in Column A3 of Schedule "B" to Schedule "Z".

**SECTION 4 - ADMINISTRATIVE**

- 4.1 Schedule "A" through Schedule "Z" are attached to this bylaw and forms a part of this bylaw.
- 4.2 If any provision of this bylaw is declared or held to be illegal, invalid, or ultra vires, in whole or in part, then the provision shall not apply and the remainder of this bylaw shall continue in full force and effect and be construed as if it had been enacted without the illegal, invalid, or ultra vires provision.
